As the commencement of the build of our facility gets closer, it is timely to acknowledge the contribution of so many people since the kernel of the wonderful vision of Peter Down, supported by spouse Margaret, took seed nearly three years ago in October 2015, which has now grown to a 112 bed facility, to be built in stages.

The HRC is planning a special function to mark the occasion as the second phase of our Gippsland \$1.5m Fundraising, at which we hope to exceed this target.

Contribution isn't only in cash terms. Other contribution in equal importance is the incredible time and effort put in by individuals to develop and realise the expanded vision, including in-kind design, engineering, and architectural services, and preparation for the integration of health and education services.

Our region is very fortunate to have such compassionate professionals.

## **Building Improvements focus on residents' recoveries**

The old saying is "if you fail to plan, you are planning to fail", and the degree of planning on multiple levels has been immense. Not only in the design and construction components, but also in primary and secondary health and education, with tertiary health in the safe hands of Odyssey House Victoria.

Enhancements to the building plans, which haven't materially affected the footprint, have improved the amenity for residents, providing an improved health care environment.

Better supporting a collaborative care model and introducing more light while identifying space savings has kept the Stage One budget at a similar level.

The updates have also required new drawings and thanks to the remarkable efforts of the Gippsland Office of Gamcorp, Structural and Civil Engineers, in Bairnsdale the second set of full plans will be ready very soon.

## **FUNDING STATUS**

## Stage 1A December TARGET now \$875k

The long awaited decision on our capital funding application to AusGov Department of Industry, Innovation and Science for\$822k under the Building Better Regions Fund has unfortunately been declined. A plethora of applicants around Australia sought a bite of the \$640m Fund.

Congratulations to Baw Baw Shire being allocated \$1.1m for their Early Learning Centre, and East Gippsland Shire being allocated \$1.5m towards their Omeo Mountain Bike Project.

This means that the HRC Board is looking for more donations to fully fund Stages 1A (cost \$7.644m) and 1B (cost \$739k) so please advocate far and wide to assist in reaching this target.

Odyssey House Victoria is negotiating with a number of Foundations which will hopefully make up some of the current shortfall, and the HRC Board is planning further functions, events and philanthropic approaches to ensure the balance is realised.
